Students enrolled in the remote learning option will participate remotely 5 days per week with five (5) clock hours of instruction/learning activities scheduled/assigned per day. Your child will not be eligible to participate in extracurricular activities during any period of time he/she is enrolled in the remote learning program.

You will need to contact your child's Principal to discuss your child's specific issues and the school district will address your child's needs and reasonable accommodations through a 504 Plan. Your child's eligibility to participate in extracurricular activities will be determined through the 504 Plan process.
